Public Concerns-Brenda received a call from Kathy McVicker questioning why the town roads were not plowed after the last snow storm. Steve explained that the county wanted to get a solid base on the road as not to push all of the gravel into the ditch. He will check the road out and if it needs plowing he will get the county out to do it.

Supervisors report

Road Updates-Schlitz Dr Steve has talked with Bernie Birkenholz with Fencing Plus regarding the gravel on that road. We are going to wait until spring and take another look at it. Currently we will not be paying the bill that was submitted as the end of November. Bernie feel that the road needs to be packed down more again we will revisit this in the spring.

New Business

1. Open bids for Electrical for doors-We did not receive any bids. The board will reach out to a local electrician,

2. Drainage Project on Spur & Cougar-Mike Hoehn is requesting that this needs to be put on the 2025 road tour and be completed in the spring. We also need to look at the culvert on Cougar. This will be passed on to the next board.
3. Community center east side entrance- the floor in the entrance is rotted out and needs to be replaced. We will get help from the community to get this project taken care of.
