Supervisors Report

1. Emery has been working on fixing and replacing road signs in the township. A lot of the post have been sheared off and some signs need to be replaced. He will be get in contact with the county and get the signs ordered that he needs.

3. Steve mentioned that talks continue with the town of Cleveland regarding the possibility of having them do the grading for the town.

Road Work in Progress

1. Grading has been completed and the trouble areas will be graded again.
2. Emery has been trimming branches as he is fixing road signs.
3. Brenda mentioned that there is a culvert that needs to be replaced on Smith Drive.

Residence Concerns

1. Chris brought in the map of the area that we will try to purchase to continue to improve our ball diamond. She let the board know about previous offers that have been made along with conversations that were had between the town and Janine.
2. Chris questioned if the Lions had there event insurance. Emery will get in touch with Dale Johnson to discuss this.
3. Chris brought up concerns about information that was given about the Audit.
4. Julie questioned what was going on with the camera and expressed her opinion of being in favor of keeping them.
5. Julie questioned why the locks need to be changed on the community center.
6. Cheryl asked about placing no parking signs near their property and along the entire road on the 4th for safety reasons.

Old Business

1. Security Camera's- Steve has spoken with the security company. He has let them know that we need to have some repair. Again we are hearing both side of being in favor and also being against them. We still need to look at the one that is facing John's house.
2. Ball Diamond-We will continue to have conversations with Janine.
