Old Business

1. Ball Diamond-The board attended the Town of McKinley's board meeting last month Steve was concerned about the soil testing that is being done on the area that we are wanting to purchase. We have been informed that the test results came back clear
2. Hand Pump-We will continue to look at ways to keep this pump. This will be brought back to the next meeting.
3. Snow Plowing-Steve has been in touch with Trawicki and Son they are still looking at purchasing a grader. The county is still willing to do our paved roads and Haas at this time will do the gravel.

New Business

1. The AVT club was present to discuss what steps need to be taken to get a portion of the state hwy open to allow ATV's to travel from Cty D into the Town of Jump River. An ordinance was written last year stating that the town was in favor of allowing them to travel on Hwy 73 in order to get into town. The next step is that the town needs to request reduction of the speed limit from Mt. Nebo to Bridge drive they are proposing a 35mph speed limit on Hwy 73 from Nebo to Bridge Drive. Brenda Miller made a motion to request a reduction in the speed limit on State Hwy 73 in the Township of Jump River between Nebo Ave and Bridge Drive to be 35 mph this was 2<sup>nd</sup> by Emery with all boards' members in favor.
2. Dump Station-Brenda made a motion to increase the dump station from \$10 to \$15 with a 2<sup>nd</sup> by Steve.
3. Worked preparation of the 2024 Budget
