Patti made a motion to approve the budget with minor changes to add to the Community Center budget an additional \$1000.00 2<sup>nd</sup> by Gary.

Old Business

1. Ball Diamond- Gary talked to Cindy's daughter she received Gary's letter and proposal. She will be here in the near future to go over this. We will put this on hold until a future date when we can get more information from her. We will not be able to start until spring now.
2. Buckhorn- Myron will check with Larry the engineer to make sure we have our final invoice from American Asphalt and we also need to get the final invoice from the engineer. Once we have all that information and payment on them we can submit to the state for approval.
3. Road to Recovery grant-We have purchased items for the fire dept. and the first responders. We will submit for reimbursement.
4. Assessor-Bids for new assessor will be opened at our December meeting.

New Business

1. Adopt local levy-Patti made a motion to adopt the local levy in the amount of \$41,822.00 with a 2<sup>nd</sup> by Gary.
2. Polling Place-Gary made a motion to no longer allow the Town of McKinley to use the Community Center for Election Day purposes. This decision was made due to the fact that their election workers have not been following state and local PPE protocol. A letter will be sent to their town Chairman regarding this.

3. Snow plow bids were opened Patti made a motion to accept the bid from Amco for all town plowing for the 2020/2021 snow season. Myron contacted Arlen regarding the bid and Arlen was only bidding for the town roads not the Community Center or the Fire department those locations have been awarded to Dick Stewart. Dick was reminded about the 3 inch rule when he was contacted about winning the bid.
